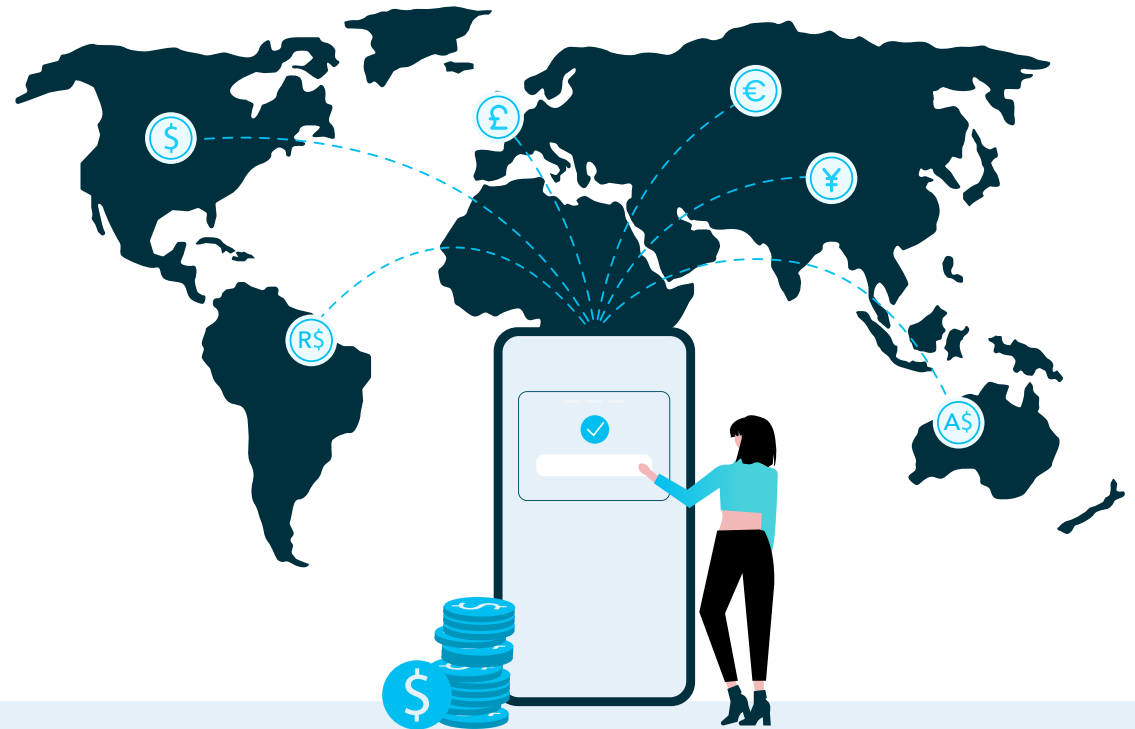

We are regulated by the Financial Conduct Authority in the UK.

Ebury Partners UK Limited is authorised as an Electronic Money Institution regulated by the Financial Conduct Authority, licence number 900797 ("UK Licence").

We operate as an EMI

As an Electronic Money Institution, Ebury Partners UK Limited does not fall under the Financial Services Compensation Scheme (FSCS). Ebury Partners UK Limited is required to protect your funds in line with the Electronic Money Regulations 2011 ("EMRs 2011"), and where applicable, with the Payment Services Regulations 2017 ("PSRs 2017"), taking into account relevant guidance published by the Financial Conduct Authority ("FCA").

We safeguard your funds

Ebury safeguards client funds by segregating them in designated safeguarding accounts with Tier 1 banks. Ebury selects these institutions to hold its client funds based on a number of factors including, but not limited to, reputational risk, agency ratings, service capabilities and local market presence. All safeguarding processes ensure that funds are appropriately protected in line with the client's agreed terms and conditions and the governing regulations.

In the unlikely event that Ebury were to cease trading, any client funds held in client accounts subject to safeguarding are protected from Ebury's creditors and should be returned to their respective beneficial owners in accordance with applicable laws.
